Terms and conditions:



Health, Safety and Hygiene:

- Prospective clients will be required to complete a consultation form prior to initial visit/ treatment which must be completed honestly, accurately and correct to the best of their knowledge.
- The client has a duty to keep Lebentz Sports Massage up to date with any changes to their health, medication, symptoms, concerns or treatments they are having investigated or undergoing treatment for.
- Clients are asked to not attend an appointment if they are unwell, suffering from a cold or virus, infection or general ill health. If you are unwell and contact us to inform us of your illness, please note our <u>Cancellation Policy</u> may still apply.
- All reasonable steps to reduce risk of COVID infection will be taken by increasing hygiene protocols, there may still however be a risk of infection from face-to-face appointments, which the client knowingly and willingly consents to in the event of a face-to-face appointment.
- GP permission may be required before your treatments can be provided, if you are unsure as to whether you may require your GP's permission, please discuss any concerns prior to booking via <u>telephone</u> or <u>email</u>.

- Treatment will only be conducted if the therapist deems treatment safe for the client to receive and may refuse to treat any client with just and reasonable cause.
- Lebentz Sports Massage reserves the right to terminate any appointment at any time if they believe that it is not safe or in the client's best interest to continue. Likewise, the client has the right to refuse, modify or terminate treatment at any time regardless of prior consent given.
- Lebentz Sports Massage does not treat anyone under the age of 18.

Payment, Gift Vouchers, Packages and Discount Codes:

- Lebentz Sports Massage accepts payment by card online.
- Gift vouchers can be used as payment towards any advertised service.
- Gift Vouchers are valid for 12 months from purchase date.
- Discount codes must be quoted at the time of booking and the discount code will be deducted at the point of payment.
- Appointments are available outside of opening hours with a surcharge as arranged upon request.

Cancellation policy/ no show policy:

- Clients are asked to provide no less than 24 hour notice when cancelling or re-scheduling appointments.

- Unless there are exceptional circumstances, cancellations made with less than 24 hours until the time of your appointment will incur the full fee charge.
- Failure to attend an appointment will incur the full fee charge.
- No additional time will be given for clients late for their appointment, the appointment will end as originally scheduled and the full fee will be payable.
- Lebentz Sports Massage has the right to cancel a treatment if the therapist is taken ill:
- A full refund will be paid in event of cancellation by Lebentz Sports Massage.

Privacy Policy:

The website uses Google Analytics to analyse visitors to the site. Google Analytics uses "cookies", which are small text files placed on your computer which collect information on visitor behaviour information such as:

Personal information:

All clients must complete a consultation form prior to receiving initial treatment. By signing the consultation form, clients are giving Lebentz Sports Massage permission to hold records and data about them. We may collect the following personal data: Client name, address, date of birth, email address, phone number, GP details, health information including medical history, diagnosis and treatment data. This is ensuring we have the right amount of information for assessing your suitability to treatment, for completing the appropriate treatment, for contacting you regarding appointment follow-ups and for a referral to GP or other healthcare practitioners if deemed necessary. All information held will be treated as strictly confidential and will only be released to any other external party with the consent of the client.

All client records are electronic and GDPR compliant.

We use CCTV technology to help keep our guests and staff safe and to help us investigate any potentially criminal or unsafe incidents which occur. CCTV footage is kept for up to 31 days. We will only share CCTV with public or regulatory authorities to help prevent crime and nuisance. We will only share CCTV if we consider a request to be appropriate.

Communication and Marketing:

Client contact data may also be used for communication and business marketing purposes. Operational communication includes but is not limited to appointment reminder emails and text messages, invoices and feedback requests.
